COMPETITION FORMAT

The Anaheim Marketplace is proud to present its Ninth Annual Ballet Folklórico Competition on **Saturday, October 20 2018**. The competition will take place during our Fall Festival of the Anaheim Marketplace (located at 1440 S. Anaheim Blvd. Anaheim, CA 92805) at **2PM**. It will be an honor to have your group participate in this year's competition.

There is no admission fee to the public. This event is being created solely to preserve the Mexican heritage through dance. We anticipate a great crowd at this event as well as a wonderful show with an amazing spirit and cultural pride.

RULES

Please be sure to read rules and regulations carefully. These rules and regulations are for your benefit. Your cooperation is required in order to prevent disqualification. *Rules subject to change.*

▪ DISCREPANCIES

We reserve the right to deny participation to anyone on the dance competition. Any group director, teacher, parent or dancer who defies any Anaheim Marketplace staff member will be removed from the premises and the group will be subject to disqualification.

▪ NO OUTSIDE FOOD

Please enjoy your delicious finds inside the marketplace. The Anaheim Marketplace does not permit any outside food or beverages. All catering, concessions, food and beverage services are provided exclusively through our in house restaurants.

Food or beverages deemed necessary due to a special dietary need, religious requirement, or medical condition may be approved in advance.

▪ DEADLINE

In order to compete, your group must be registered by **October 5th, 2018 by 6:30pm**.

▪ REGISTRATION FEE

Early Bird Registration: \$50 – Payment must be paid in full by August 17th.

Regular registration: \$80 – August 18th-September 28th: Payment must be paid in full by September 28th.

Late registration: \$100 - September 29th - October 5th. Payment must be paid in full by October 5th.

The registration fees are non-refundable.

- PERFORMANCE

Each group is allowed a minimum of 4 dancers and a maximum of 18 per group.

Entries will only compete against competitors of *equal* age group or with the exception of a younger competitor moving up an age group. For example, a 9 year old competitor can compete with the age group of 10-15 *but* cannot compete again with its age group. Therefore all performers must present any form of valid identification or birth certificate. All paper work must be submitted by October 5th, 2018 by 6:30pm.

- AGE GROUPS

- Ages 9 and under
- Ages 10 – 15
- Ages 16 and over

- REGIONS

- Central Mexico - Includes Michoacán, Nayarit, Zacatecas, Aguascalientes, and Jalisco
- Veracruz
- Southern Mexico - Includes Guerrero, Puebla, Oaxaca and Yucatan
- Northern Mexico - Includes Sinaloa and Tamaulipas
- Baja California - North or South

- CAMERAS/VIDEO

Any type of photo and/or video camera will not be allowed in front of the stage. Video cameras with tripods will not be allowed in the hallways for safety reasons. Also, please avoid using flash as it may not be necessary and it may disturb the dancers. There will be a designated area to take pictures and video.

- MUSIC

You must present one (1) CD per age group to the DJ fifteen (15) minutes before your performing time. The CD must clearly be identified with the **name of the group, age group and region.**

- MONOGRAPH

All groups must present a monograph in Spanish before the dance begins. The monograph must be done by a dancer or teacher. The monograph must be between *one minute* and *one minute and a half*.

The monograph may include a description of the region, culture, attire, and/or music. For example, you may have one dancer, a couple or the entire group as you speak about the group's costumes. Stage props may be used during introduction. If fire or incense are going to be part of the performance please make sure to mention it in your application. If you need any special accommodations, please advise the event coordinators ahead of time.

Be as *creative* as you like, but keep in mind that you only have *one minute* for the introduction.

▪ **PERFORMANCE TIME**

Each group is allowed a **minimum of seven (7) and a maximum of ten (10) minutes to perform** including monograph, entrance and exit.

Ten (10) points will be deducted if you exceed the time limit. No exceptions.

JUDGING CRITERIA

Experienced instructors and/or directors will judge the competition. Points are scored as follow:

Monograph.....	10 Points
Music – True to region	10 Points
Costumes/ Appearance – Makeup and Accessories fits region	20 Points
Precision and execution of steps.....	20 Points
Expression and Movements.....	15 Points
Choreography and Stage Use.....	20 Points
Showmanship and Enthusiasm.....	10 Points
Originality.....	5 Points

A maximum of 110 points can be scored by each group during the competition.

Although the Anaheim Marketplace instills traditional folkloric, groups are allowed to be as original, unique, and creative as they want to be with their choreography and/or costumes *as long as these are kept true to the region* they are representing during the competition.

PRIZES

First, second, and third place winners will receive cash prizes. First, second, and third place will also receive a trophy or plaque.

***Cash prizes are subject to change.**

All groups will receive a certificate of participation.

DAY OF COMPETITION

- Groups must be checked in at the Registration Desk in La Placita by 12:00 PM. Upon registration you will be handed out a performance schedule and colored wristbands to each age group.
- Dressing rooms will be available at first come first serve basis. We encourage contestants to come in costumes when possible. Each group is responsible for its belongings.
- All groups must be ready fifteen (15) minutes before their performance time behind the stage.
- The competition will begin exactly at 2:00PM.
- There will be a break between age group competitions.
- Food and beverages will be sold at the venue.

AWARD CEREMONY

A group member (i.e. Director or dancer) will need to go up on stage during the awards ceremony. This person will be up on stage along with the members from other groups. Once on stage, please do not leave until the awards ceremony has finished.

In consideration of being allowed to participate as a student, player, observer, coach, team captain, instructor, lecturer, organizer, or in any capacity whatsoever, utilizing any of the facilities at Anaheim Indoor Marketplace, including the sporting venues, soccer arena, Studio, or Hall, (hereinafter the "Marketplace Facilities"), or such other activities as may be contemplated (the "Activities"), the undersigned participant (hereinafter "Participant"), on behalf of the Participant and Participant's heirs, successors and assigns, hereby waives all claims of whatever nature, and forever releases, remises, acquits, discharges and holds harmless Anaheim Indoor Marketplace, including its affiliates, subsidiaries, licensees, sponsors, advertisers, and each of their respective directors, officers, shareholders, partners, owners, agents, employees and all other persons, firms, corporations, associations or partnerships associated therewith (collectively "Releasees"), from any and all claims, demands, actions or causes of action arising out of or related to any losses or injuries to the person or property, or both ("Claims and Damages"), of Participant which may result, be claimed, sustained or received by Participant as a result of Participant participating in the Activities.

Should any legal action or proceeding be commenced by either party hereto in connection with this Release Agreement, the prevailing party or parties shall be entitled to recover from the losing party the prevailing parties' actual attorneys' fees and costs incurred in connection with such action or proceeding.
